How do you embody the spirit of a Cane?

Aaron Marckell Williams embodied the spirit of a Cane through his unwavering commitment to service, leadership, and community. As a resident assistant, mentor, brother of Omega Psi Phi Fraternity, Inc., and later as a photojournalist, he used his talents to uplift others and tell stories that mattered. He led with humility, served with purpose, and left a lasting impact on everyone he encountered. Aaron showed that being a Cane isn't just about what you achieve, it's about how you inspire, support, and elevate those around you.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

One of the greatest lessons Aaron likely gained at the University of Miami was that leadership is rooted in service. Through his experiences as a student leader and mentor, he learned that making a lasting impact comes from investing in others. That perspective shaped the way he lived after graduation, using his career in photojournalism not just to document moments, but to amplify voices, preserve stories, and strengthen the communities he served. It was a uniquely Miami experience that stayed with him long after he left campus.

What is/are your most noteworthy accomplishment(s) after graduation?

After graduation, Aaron Marckell Williams continued to embody the values of leadership, creativity, and service that defined his time at the University of Miami. One of his most noteworthy accomplishments was building a career as a photojournalist with The Washington Informer and AFRO, where he used his camera to capture the dignity, culture, and lived experiences of the communities he served.

Aaron was more than a photographer, he was a storyteller who believed every person had a story worth telling. Through his work covering political, religious, and

community events, he preserved meaningful moments and highlighted the people and experiences that often go unseen. His colleagues remembered him for his creative eye, passion for photography, positive spirit, and his ability to bring heart and intention to every assignment.

Beyond his professional accomplishments, Aaron's greatest impact was the way he inspired others. He encouraged people to embrace their creativity, live authentically, and recognize the power of their own stories. Whether traveling the world, connecting with people, or capturing moments through his lens, Aaron lived by the belief to "always capture the moment." His legacy is a reminder that success is not only measured by achievements, but by the lives you touch and the stories you leave behind.

How do you embody the spirit of a Cane?

During my first year, I learned that the Ibis is the last bird to leave before a hurricane and the first to return. That immediately resonated with me because it reflects exactly how I move through the world. I stay committed through difficult moments, I show up when people need me, and I'm often the first person others turn to for help.

As a teacher in Title 1 School, I found myself stepping into both literal and metaphorical fires. I was there not only to steady the situation, but also to rebuild. In my professional and personal life, I make decisions carefully, always considering how they affect the people around me, and I often put others before myself.

To me, that's the spirit of a Cane, just like the Ibis. I stay with my community, I don't leave people behind, and I'm always ready to lead. Every opportunity I take and every risk I embrace comes from that same commitment to showing up and standing strong for your community.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

Working with students in foster care as a youth coach with the University of Miami Family Law Clinic's First Star U program taught me that being a strong role model is more powerful than anything you can teach or tell someone. Patience, consistency, and thoughtful actions matter, especially for young people who come from unpredictable environments and have every reason to be cautious around authority. I learned that trust is never assumed; it's earned through reliability.

As a teacher, I was often the first male Latino teacher and one of the youngest my students had, so I had to embody the behavior I wanted to see from them while representing the best versions of myself and community. I built trust with diverse students, families, coworkers, and administrators the same way I learned how to do that with my foster care students: by showing up, following through, and staying steady. That experience shaped how I lead, how I teach, and how I continue show up for others.

What is/are your most noteworthy accomplishment(s) after graduation?

After graduating, I chose to stay in Miami even though it was not where I was born or raised. I wanted to make it my permanent home after realizing that no other place would make me feel like I belonged the way Miami does. Building a strong community here and giving back through local organizations has mattered more to me than any title or accolade. Still, I'm proud of what I've accomplished in the three years since I graduated.

I became the first and only teacher to complete both Teach For America and the Teacher Accelerator Program, and I continue to mentor new educators, including running my own mentorship group. I've taught over 300 students in 3 years, and both times I taught tested subjects, my classes consistently outperformed district averages, even at a school ranked among the lowest in the district. Keep in mind that I had to learn three different curricula in just three years as I taught a different grade and subject every year. I worked with students with disabilities, newly arrived immigrants, and highly advanced learners, sometimes managing classes of almost 40 kids on my own from all backgrounds.

I was nominated for and won Teacher of the Year twice in a row. I was accepted into the Peace Corps, ultimately choosing to pursue a Fulbright, which I'm thrilled to have received. I was also nominated for the Teach For America Excellence in Teaching Award.

Beyond the classroom, I earned an LEE Public Policy Fellowship, working with Miami-Dade District 9 School Board Member Luisa Santos to help write policy that is now being implemented, using my experience as a teacher to shape and build crucial systems. Today, I serve as the only outreach coordinator for Florida's official gambling addiction helpline, leading statewide efforts in a field with very few

dedicated professionals, but a high demand for awareness on a very serious and prevalent issue. In my new role I am still able to give back to community, but at a much larger scale and work with even more diverse populations, while still being an educator of sorts.

What is/are your most note-worthy accomplishment(s) after graduation?

After graduating from the University of Miami, my most meaningful accomplishment was building a career where I can create impact while continuing

to serve others. At Blackstone, I contribute to global technology and process improvement initiatives that have helped strengthen the firm's technology operations, enhance user experiences and support measurable business outcomes. Equally important, I have been actively involved in Blackstone's Military Internship Program (MINT) – supporting programming, coordinating events, facilitating mentorship opportunities, and serving as the interns' point of contact. Having made the transition from military to civilian life myself, I take great pride in helping fellow veterans build connections and explore new opportunities as they take the next step in their professional journey.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

One of the most valuable lessons I learned at the University of Miami was that success doesn't require sacrificing the experiences that make life meaningful. I was surrounded by people who were deeply committed to their academics, leadership roles, and future careers while also embracing the vibrant campus community and

enjoying the unique energy of Miami. That balance is something I haven't experienced anywhere else.

Being involved in Greek life, student government, and other campus organizations introduced me to people with different backgrounds, interests, and aspirations. This broadened my perspective, challenged me to become a better leader, and helped me build friendships that continue today. What stood out most was how welcoming and connected the community was despite our different paths.

That perspective has stayed with me throughout medical training and into my career. What is/are your most note-worthy accomplishment(s) after graduation?

Since graduating from the University of Miami, I have focused on building a career that combines clinical excellence with research to improve the quality of surgical care.

After medical school, I began my general surgery residency, where I developed the foundation to care for patients through some of their most complex and challenging experiences. Recognizing my passion for academic surgery and healthcare improvement, I took dedicated time from residency to serve as an American College of Surgeons Clinical Scholar. During this nationally competitive research fellowship, I also earned a master of science in health services and outcomes research from Northwestern University, strengthening my ability to use data and evidence to improve patient outcomes.

Throughout this time, I have been fortunate to contribute to surgical research through peer-reviewed publications, presentations at national and international scientific meetings, and successfully obtaining competitive research grant funding. These experiences have allowed me to collaborate with multidisciplinary teams and contribute to projects that aim to improve the safety, quality, and value of surgical care.

While I am proud of these academic accomplishments, I am most proud of the impact they represent. My goal is to build a career as an academic surgeon who not only provides exceptional care in the operating room but also advances the science of surgery, improves healthcare systems, and mentors the next generation of physician leaders.

How do you embody the spirit of a Cane?

Besides my obsession with University of Miami memorabilia like my license plate, the UM helmet in my office, and the UM coasters in my dining room, I think I embody the spirit of a Cane every day.

To me, embodying the spirit of a Cane means approaching each day with a positive mindset, stepping out of your comfort zone, leading with integrity, and demonstrating creativity in the workspace. These are all characteristics I have observed or learned from my colleagues at the University of Miami, and they have been the most valuable skills for me in approaching the legal profession and the novel challenges it can present daily.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

During my time at the U, I was a biomedical engineering student who had no interest in pursuing a career in law until my senior year. Two experiences changed the trajectory of my entire life and career, and make me thankful everyday that I am a Cane! First, during my studies, the College of Engineering required all biomedical engineering students to enroll in a regulatory controls course, which was not customary for similar programs at other institutions. This class was my first experience with the intersection of technology and law/regulations. Throughout this required course, which was unique to the U, I became obsessed with the ways laws were shaping companies developing health care technologies, and quickly made the decision to pursue a career in the legal field or regulatory controls.

Prior to this experience, I joined the University of Miami's First Star College Preparatory Academy as a youth coach/counselor. First Star is a program designed

to bring foster youth to college campuses, so they can get the tools they need to successfully matriculate into a four-year institution after finishing high school. I was passionate about this project, which was an opportunity to help teens from a similar socioeconomic background as myself, and from a similar region (South Florida) understand they could use academia to author their own destiny as I did.

During my time at First Star, Kele Stewart, a professor in the law school, and one of the powerhouses behind this program, asked me whether I had ever considered being a lawyer. At the time I was reluctant to engage with this question, but Kele listed multiple traits and skills I exhibited in my role that would translate to being an excellent lawyer. She was right, but I didn't figure that out until I took regulatory controls later.

These are two perfect examples of lessons and experiences that I could not have gained at another institution. The University of Miami is more than an institution, it is a community offering unique experiences where people see the potential in you and push you to be the best version of yourself.

What is/are your most noteworthy accomplishment(s) after graduation?

I started my legal career at a well-respected full service AMLAW 200 law firm, Burr & Forman LLP, and [I am also proud of] my role as editor-in-chief of University of Florida's Journal of Technology Law & Policy, which was a top ten science, technology, and computing law journal during my tenure as editor-in-chief.

My participation in the inaugural class of the Innovation and Entrepreneurship Clinic at University of Florida's law school gave me the opportunity to learn legal fundamentals of artificial intelligence, intellectual property, and data privacy while working closely with innovators and business owners. My participation in the Veterans and Servicemembers Legal Clinic at the University of Florida was a wonderful opportunity to use my legal training to give back to some of the most selfless people in our nation. I was able to build strong client communication skills and develop my advocacy skills under the guidance of an expert litigator. Together, as a team, we used our skills to obtain multiple discharge upgrades for well deserving veterans who were struggling without the benefits associated with being honorably discharged, which they rightly deserved.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

The one experience I couldn't have gained anywhere else was walking into Michelle Kaufman's sports journalism class. Before coming to the University of Miami, I had heard stories about women doing incredible things in sports media, but I never imagined that one day I would be sitting in the classroom of someone I admired so much.

Michelle became so much more than a professor. She became my mentor, my friend, and the voice of reason whenever I felt like giving up. Her class wasn't just

another course it was an open door that completely changed the trajectory of my life.

Because of that opportunity, I covered the Miami Heat, the Miami Dolphins, and the Miami Marlins. I interviewed world-class athletes, stood on professional sidelines, and found myself in rooms that a little African girl from Zimbabwe could have only dreamed of. What is/are your most noteworthy accomplishment(s) after graduation?

One of my biggest fears throughout college was public speaking. Even after graduation, that fear still lingered. So when I was invited to speak at a TedX event at the University of Miami, it became one of my proudest accomplishments. Since graduating from the University of Miami, I've continued pursuing creative and adventurous hobbies—from stop-motion animation to rock climbing, a passion I first discovered during my senior year at Miami. After being honored as a Goldwater Scholar during my junior year, I've had the privilege of serving on the Goldwater Scholarship selection committee, helping recognize the next generation of student researchers.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

One of the greatest gifts the U gave me was the freedom to explore broadly. Through the Foote Fellows Honors Program, I was able to pursue my interests across disciplines, graduating with five minors (philosophy, English literature, political science, management, and studio art) in addition to my degree in psychology.

That interdisciplinary perspective has shaped everything I've done since. It influences my Ph.D. research on the behavioral science of climate action, where

solving complex societal challenges requires insights from many fields, and it continues to inspire my creative pursuits, including filmmaking and painting.

What is/are your most noteworthy accomplishment(s) after graduation?

Since graduating, I have been fortunate to receive several national fellowships, including the NSF Graduate Research Fellowship and, more recently, a National Institute of Social Sciences dissertation grant. I have also published 13 peer-reviewed articles in leading journals such as Nature Communications, PNAS Nexus, and Science Advances, and have presented my research at conferences around the world.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

One lesson I gained is captured in the message of my TEDxUMiami talk: Storm Preparedness 101. The University of Miami taught me that success is not about avoiding storms, it's about learning how to weather them. During my college journey, I faced challenges that tested my resilience and determination. There were moments of uncertainty, financial hardships, and obstacles that could have easily derailed my goals. Yet, through the support of the Cane community, life-changing scholarships, and opportunities such as being awarded funding through the amazing God's Plan moment, I learned that even the most difficult storms can carry unexpected blessings.

Since graduating from the University of Miami, one of my most noteworthy accomplishments has been serving as a senior project manager leading a regional collaborative in central North Carolina through its first official Community Health Needs Assessment (CHNA) cycle as the Central Carolina Community Collaborative. In this role, I lead the alignment and collaboration efforts across 27 hospitals, 10 health departments, 4 United Way agencies, and several community organizations, technical vendors, and academic partners, bringing together diverse organizations around a shared vision for improving community health.

I am especially proud that this work has extended beyond our region and contributed to national conversations around community health improvement. How do you embody the spirit of a Cane?

I embody the spirit of a Cane by recognizing that excellence is rooted in service, inclusion, and community. Some of my favorite memories at the University of Miami were volunteering through UM Days of Service, participating in Hurricanes Help the Hometown, helping plan and raise funds for Relay for Life, and teaching children poetry through Written in My Soul. Those experiences showed me the impact of serving alongside others and strengthened my lifelong commitment to giving back.

That commitment has guided my journey as a dermatology resident. Through my research, I have worked to improve the representation of skin of color in medical education, expand access to accurate dermatologic information through innovative platforms like TikTok, and advance more equitable care for underserved communities. Through advocacy on Capitol Hill, I have also championed policies that expand access to high-quality dermatologic care.

I intentionally chose to complete my dermatology residency at Howard University Hospital because I wanted to train in an environment where serving underserved communities is central to the mission. In the clinic, I strive to embrace diversity by listening to my patients' experiences and working to ensure that every patient feels seen, heard, and represented. Outside of the clinic, through my service organization, I work directly with the community to provide skin health education and distribute free skincare products to under-resourced communities in the D.C. area.

Being a Cane means carrying forward the values that the University of Miami instilled in me: compassion, service, collaboration, and a responsibility to use my education to improve the lives of others. Whether through research, advocacy,

education, or patient care, I hope to leave every community I join stronger than I found it. And, of course, I continue to carry my Cane pride with me—during football season, you can often find me wearing a UM sweatshirt or other Hurricanes gear to clinic each week, cheering on the Miami Hurricanes while representing the community that helped shape who I am.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

Looking back on my time at the University of Miami, the one perspective I gained that I do not think I could have gained anywhere else is the importance of an institution that truly invests in its students. At the U, I felt that the university was not just a place where I attended classes, but a community that actively supported my growth, aspirations, and success.

From free campus events and traditions like Pancakes with Pat, Canes Night Live, and SportsFest, to UM's willingness to support student organizations, ideas, and initiatives, UM created an environment where students felt valued and empowered to get involved. Some of my favorite memories came from these traditions and the sense of community they fostered, including competing in SportsFest with my dorm communities at Mahoney-Pearson and later at University Village, where we won both times. These experiences showed me that the U was not just about academic achievement, but also about building lifelong connections and creating opportunities for students to come together.

I was also fortunate to have access to mentors, deans, and administrators who were approachable, responsive, and genuinely invested in helping students succeed. That commitment extended beyond campus life and into my professional journey. As a student interested in medicine, I benefited from programs such as the Miller School of Medicine MCAT Preparation Program and the Motivations Program, which helped support students from underrepresented backgrounds pursuing careers in medicine. I was also able to engage in undergraduate research because of the incredible opportunities available at UM. Through my connections at UM, I was blessed to meet my esteemed mentor, Dr. Heather Woolery-Lloyd, a UM physician herself, whose mentorship, guidance, and support became one of the most influential factors in my journey toward dermatology.

The lesson I carry with me is that when an institution believes in its students and provides them with resources, mentorship, and opportunities, it can change the trajectory of their lives. UM taught me the value of creating communities where people feel supported, seen, and encouraged to pursue their biggest goals—and that is a lesson I continue to carry with me today.

What is/are your most noteworthy accomplishment(s) after graduation?

My most noteworthy accomplishment after graduation has been co-founding Community Skinterventions in 2022, a nonprofit dedicated to improving access to dermatologic care and education for historically marginalized communities in Washington, D.C. Throughout my medical training, I recognized that many communities face barriers to receiving timely, culturally relevant dermatologic care, and I wanted to create an organization that brings education and resources directly to where people are.

Through Community Skinterventions, we have organized 25 educational events reaching more than 1,500 community members. We have provided free skincare products and culturally tailored educational materials on topics including sun safety, melanoma detection in darker skin, atopic dermatitis, acne, and how to navigate access to dermatologists who accept Medicaid and Medicare. Most recently, we expanded this mission internationally by helping coordinate a Community Skinterventions educational event in Nigeria.

Beyond providing resources, I have personally engaged with community members in shelters, parks, sports courts, health fairs, and through street medicine programs—meeting people where they are, answering their questions, and empowering attendees to advocate for their own dermatologic health. We published this work in the *Journal of Drugs in Dermatology* to encourage other healthcare professionals to develop similar community-based initiatives. I have also advocated for systemic change by meeting with state representatives on Capitol Hill to address policies affecting access to dermatologic care. This work has reinforced my belief that improving health equity requires not only treating patients in the clinic, but also educating communities, addressing barriers to care, and advocating for policies that ensure all individuals have access to high-quality dermatologic healthcare.

How do you embody the spirit of a Cane?

Working in policy and politics demands resilience. I hear “no” almost daily, from legislators, editors, and other powerful people. If I took “no” for an answer, I’d never make progress or drive change. So, like the ibis, who is the last to leave and the first to return home after a hurricane, I hold onto my purpose and keep pressing forward.

Resiliency for its own sake is wasted energy — it’s only when applied toward the greater good that it drives real, meaningful change. During our first year, “Canes Care for Canes” was drilled into our heads, and I took it to heart. My purpose in policy work is to build a better country for my broader community, and I pursue that by advocating for patients to have access to higher-quality, more affordable health care. I carry the spirit of a Cane into every fight: resilience with purpose, in service of the people I represent.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

During my final semester at the U, I interned with the member of Congress in whose House district the University sits. I went in wanting to give back to and learn more about the community outside our campus bubble, but the experience showed me how much that community had shaped my time in Miami without ever realizing it.

Constituents in our district brought the same concerns to their member of Congress that I now spend my career working on. That’s not something you learn in a classroom; you only see it by stepping outside the campus gates and into the district that makes the University possible in the first place.

While it's usually the first thing overlooked, the community surrounding a university is just as much a part of its identity as the students inside it. That internship is where I first understood that advocacy starts with the community right in front of you.

What is/are your most noteworthy accomplishment(s) after graduation?

My job often has me testifying before legislatures and appearing in the media advocating for patients nationwide — and I've helped bring about many meaningful changes — but my favorite accomplishment happened on my own time, in my own city.

A security guard confiscating my pepper spray at a concert turned into the first piece of legislation I ever influenced. Frustrated after losing it at the door, I went home to reorder one online, only to find that Amazon and every major retailer refused to ship to my D.C. address, even though possessing pepper spray for self-defense is completely legal in the district. I dug into the code myself and found the real story: D.C. had repealed its registration requirement years earlier, but retailers never got the memo, leaving residents in a city with rising crime rates unable to protect themselves with something as basic as pepper spray.

I funneled my frustration into an op-ed, published in the Washington Examiner. The piece caught the attention of a D.C. City Council member, and the issue was eventually addressed in legislation, with the council member publicly acknowledging my role in bringing it to light. Since then, I've heard from women thanking me for helping them feel a little safer in a scary world. I was 23, and it was the first time I saw firsthand that one person paying attention to a small, overlooked problem can actually change the law and make a difference.

Postdoctoral Research Fellow, Shedd Aquarium

How do you embody the spirit of a Cane?

To me, being a Cane means leading with curiosity, resilience, and a commitment to making a difference. At the University of Miami, I learned and saw in real time how science and conservation not only overlap but how imperative it is that that work connects to the community, both campus- and Miami-wide. That mindset has shaped my career, from working alongside researchers and restoration practitioners to mentoring students interested in conservation. Whether I'm working with researchers across institutions, partnering with coral restoration practitioners, or mentoring the next generation of conservation scientists, I try to build the same kind of supportive community that helped shape me as a student. I hope to leave every project and every person a little better than I found them.

Looking back on your time at the U, what is one lesson, experience, or perspective that you couldn't have gained anywhere else?

The biggest lesson I learned at Miami was that you don't have to wait to make meaningful contributions to science. As an undergraduate working at the Rosenstiel School, I wasn't just observing research, I was trusted to be part of it. That experience gave me the confidence to ask ambitious questions, and see myself as a scientist. There's nowhere else I could have combined world-class marine science, direct access to cutting-edge coral reef research, and mentors who believed in me from such an early stage. Those experiences set the foundation for everything I've accomplished since.

What is/are your most note-worthy accomplishment(s) after graduation?

After graduating from the University of Miami, I earned my Ph.D. in Biology at Penn State University, where I studied how genetic diversity can help endangered coral populations adapt to a changing climate.

Today, as a postdoctoral fellow at Shedd Aquarium, I use whole-genome sequencing to identify corals that are naturally more resilient to heat stress, helping restoration practitioners make more informed decisions about which corals to propagate and outplant. My research has contributed to publications in journals including Science Advances, PNAS, and Evolution, and in 2025 I was honored to receive the Biota Postdoctoral Fellowship from the Walder Foundation to expand this work and to generate recommendations that coral restoration practitioners can actually employ from genomic data I generate. What I'm most proud of, though, is seeing our research move beyond the lab and become a tool that supports the long-term conservation of coral reefs.
